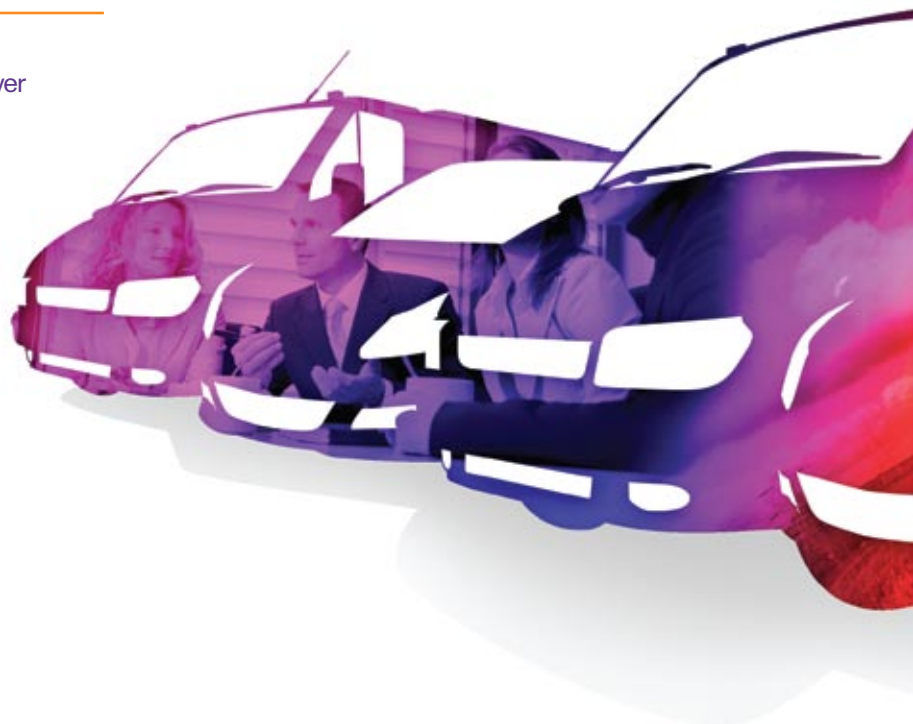

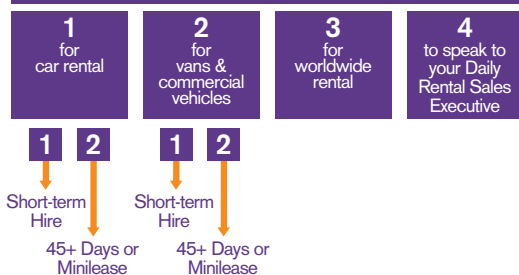


How to book your Minilease

Open ended reservations

For maximum convenience, you can make reservations without specifying a termination date. When you've finished with the vehicle, simply call 0844 879 6666 and we'll take it from there.

Early termination

Should you need to terminate a vehicle before the 84 day minimum period has expired, your agreed standard daily rental rates and sundries will apply instead of the preferential Minilease rate.

Insurance

Vehicles must be covered by a fully comprehensive insurance policy. This applies to **all** vehicles including any changeover vehicles. Supplier Damage Waiver cover can be arranged at the time of booking, subject to driver qualification. This must be requested at the time of booking, and additional charges will apply.
